It has been an eventful 2024-2025 year for our judo club.

We have had the opportunity for various regional training events for our junior and senior judokas with clubs in Cranbrook, Invermere, and Fernie, including hosting a referee seminar in September and Petite Samurai training in Creston in October.

Fundraising efforts have been ongoing with bottle drives and the Valetine fundraiser with roses donated from Pealows. Tara and Laura were also instrumental in seeking sponsorships from several local businesses.

Our judokas travelled into Alberta and across BC to attend different training camps and tournaments. Our senseis won double gold at the BC Open in Vernon and one of our senior judokas attended the BC Judo Provincials in Prince George. We also had two in-house tournaments – the Post Turkey Throwdown Showdown and the Pre-reindeer Rumble.

We have been seeking a different space for our dojo for a number of years. A few months ago, an opportunity came up for us to move into a new space at the former fire hall. This space has given us more area to train, is more accessible, and is a more visible and centralized location.

I am thankful for our small, but active board of directors who have been able to guide this club through the season.

### Appendix 3 - Coaches Report

Coaches report for the 2024/25 season:

The 24/25 season was a season of ups and downs. More focus on training camps instead of tournaments this last season. We attended 4 tournaments throughout BC and AB, with our novice athletes really shining.

We attended 8 training camps, 3 in the Kootenay's, 2 in Alberta. And 2 Kata training camps. All were well attended, and the kids and Sensei learned a lot.

The next seasons timeline is being adjusted due to the constant trend of athlete drop off in the month of May and the season end BBQ will continue to reflect that this year. Also, instead of doing a Blossom fest float we are going to consider a Christmas parade float. It aligns better with our season.
